# KAILASH MANASAROVÁR YATRA DECLARATION BY APPLICANT

### PERSONAL DECLARATION

I hereby confirm my participation in the Tour organized by SARVA TOURS & TRAVELS and shall abide by all the implemented rules and regulations and the following terms

- I release SARVA TOURS & TRAVELS and its officers, employees, agents, licensees, guides and all other representatives
  and the land management authorities in the countries in which the trip is conducted (each of whom are collectively referred to
  as SARVA TOURS & TRAVELS and its employees from all costs, liability, loss or damage incurred or suffered by me directly
  or indirectly during the course of the Yatra and resulting to my personal injury, illness or death or damage to or loss of my
  property.
- 2. I understand hereby undertake that in case of loss of my life on Chinese territory during Yatra, the decision regarding cremation of mortal remains at site (i.e. Chinese territory) shall be left to Liaison officer of the batch who will not be bound to seek prior consent of my family members or relatives.
- 3. I undertake that I will bear full responsibility for expenses on emergency medical treatment as well as emergency air evacuation (4,00,000 INR) or emergency evacuation by road (1,00,000 INR), if the need arises during the Yatra.
- 4. I waive any claims I have or may have at any time against SARVA TOURS & TRAVELS and its employees and I agree by accepting the additional inherent dangers and risks associated with the trip, not to make any claim against or seek any compensation from SARVA TOURS & TRAVELS and its employees in respect of any personal injury, illness, death suffered by me or damage to or loss of property sustained by me as a result of my participation in the Yatra. I understand that I am travelling at my own risk.
- 5. I understand and accept that due to the nature of travel in the mountain and also due to certain terms and conditions imposed upon SARVATOURS & TRAVELS by the principals' i.e the Chinese Travel Authority. I will not be eligible for any refund of the cost for whatsoever reason when the trip is actually launched and if I make a cancellation after completion of booking formalities I lose the amount mentioned according to the clauses of cancellation policy.
- 6. I understand that I am liable to pay SARVATOURS & TRAVELS the remaining amount for the tour 30 days before the departure date. I understand on failing to do so my trip will be automatically cancelled and I lose the amount as per the cancellation policy.
- 7. I understand that in case of any cancellation of the trip by me under any unforeseen circumstances I am not liable to get any sort of refund from SARVATOURS & TRAVELS.
- 8. I have read all the terms and conditions listed in this booking form thoroughly and have fully and clearly understood the information on the trip. I have also understood the itinerary and all other written material issued by SARVATOURS & TRAVELS and also explained by SARVATOURS & TRAVELS TEAM very clearly for the trip I have applied to join.
- 9. I am abiding to pay SARVATOURS & TRAVELS any extra charge levied by China Travel Authority (CIPSC & TTB) due to their frequent change in policies in very short notice. I will forfeit all amounts to SARVATOURS & TRAVELS if I do not pay this amount.
- 10. I understand that if SARVA TOURS & TRAVELS cancels trip or there is a need arise to return back from the half way due to unavoidable circumstance beyond our control such as political unrest, natural calamities, changes in itinerary by the Chinese authorities, limited number of pilgrims allowed by Chinese authorities (Quota system imposed by CIPSC at any time) etc. I will not be eligible for any refund from SARVATOURS & TRAVELS nor will be eligible for any claim for any loss whatsoever.
- 11. I hereby submitting medical certificate by certified doctor for the yatra which mentions my physical fitness is up to the mark for this journey.
- 12. SARVA TOURS & TRAVELS will not be responsible for helicopter/flight/bus/car delay/cancellation in/out from Nepal,Nepalgunj,Simikot,Hilsa, Kodari/Zhangmu/Lhasa/Ali/Kerung or anywhere during the trip due to any reason. Yatris must themselve pay for extended days stay for hotel,food etc than and there. SARVA TOURS & TRAVELS hold no responsibility of any economical loss due to this.
- 13. Yatri must pay to hotel directly for any extra nights stay in Lucknow, Kathmandu, Nepalgunj, Hilsa and Simikot other than mentioned nights stay in itinerary because of flight delays, bad weather etc.

## **Cancellation Policy:**

- 1. Consultation Fee Rs. 20,000/- non refundable.
- 25% Cancellation charges of the package cost In case if cancellation is received between 29-20 days 50% Cancellation charges of the package cost In case if cancellation is received between 19-08 days 100 % Cancellation charges of the package cost in case if cancellation is received prior to 7 days.
